**RESOLUTION RECONFIRMING APPOINTMENT
OF ADA COMPLIANCE OFFICER CINDY VENEZIANO**

WHEREAS, on February 27, 2006 and July 31, 2007, complementary Consent Orders were entered into between the Advocates for Disabled Americans, et al. and the Township of Middletown in the matter of *Advocates for Disabled Americans, et al. v. Township of Middletown* that, in part, required the appointment of an ADA coordinator responsible for the receipt and response to all resident complaints and queries regarding ADA compliance; and

WHEREAS, before August 15, 2007, the Township's EEO Officer, Cindy Veneziano, was appointed by the Township Administrator at that time to serve as the Township's designated ADA Compliance Officer and has continued to serve in that capacity since that time and has addressed a number of accessibility issues including ones raised by the Plaintiffs in this matter; and

WHEREAS, Cindy Veneziano, as the Township's designated ADA Compliance Officer, has received specialized training with respect to accessibility issues; and

WHEREAS, since January 8, 2008, Cindy Veneziano's contact information as the Township's ADA Compliance Officer has been made readily available by a link provided for on the front page of the Township's website along with a copy of the Consent Order in this matter; and

WHEREAS, it is recommended by the Township Attorney that this Resolution be adopted to formally reconfirm Cindy Veneziano's appointment as the Township's ADA Compliance Officer with another Resolution and/or Ordinance to be considered during reorganization for 2011.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown that Cindy Veneziano is hereby reconfirmed as originally appointed by the former Township Administrator to continue to serve as the Township's designated ADA Compliance Officer in conformance with the Consent Order entered July 31, 2007 in the matter of *Advocates for Disabled Americans, et al. v. Township of Middletown*.


